LIMITED POWER OF ATTORNEY FOR
SECTION 16 REPORTING OBLIGATIONS

Know all by these presents, that the undersigned hereby makes, constitutes and appoints the following persons from FibroGen, Inc., a Delaware corporation (the "Company"): Juan Graham, Michael Lowenstein, John Alden, Michael Hom, Cecelia Monoarfa-Taime, Michelle Simonetti, Tricia Stewart, and Faith Holle, and certain employees of Cooley LLP, the law firm retained by the Company, specifically Eric Steiner, Justin Kisner, Nancy Wojtas, Julia Stark, Brett White, and John McKenna, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

(1) prepare, execute, acknowledge, deliver and file Forms 3, 4, and 5 (including any amendments thereto) with respect to the securities of the Company, with the SEC, any national securities exchanges and the Company, as considered necessary or advisable under Section 16(a) of the Securities Exchange Act of 1934, as amended (the "Exchange Act") and the rules and regulations promulgated thereunder, as amended from time to time;
